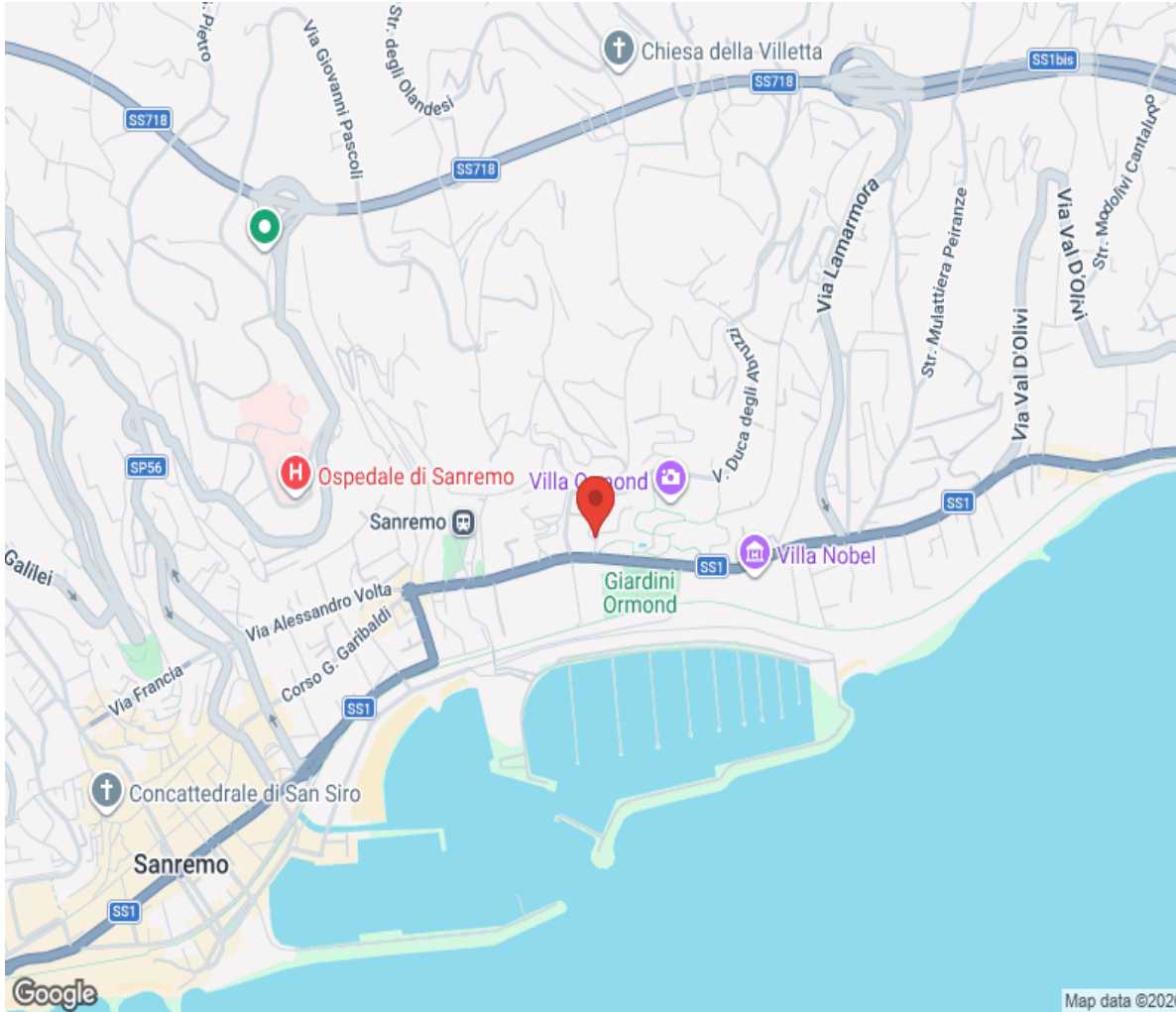

It is not an immediately available home, but it represents an interesting opportunity to acquire a well located property in a highly sought after area. What does bare ownership mean in Italy? Bare ownership, known in Italian as "nuda proprietà", means that the buyer purchases the ownership of the property, while another person retains the usufruct for life. The usufructuary has the right to live in and use the apartment, while the bare owner becomes the full owner only when the usufruct ends. For buyers, this type of purchase is usually considered a medium to long term real estate investment rather than a property for immediate personal use.
